The Construction Phase Plan for each site includes an environmental risk assessment which is utilised by the site team to identify key local sensitivities and highlights the need to contact neighbours and adjacent business of the proposed construction works.

MCL place a very high priority on the safety of it's employees and members of the public.

All work areas will be securely fenced off using a secure fencing system and maintained throughout the currency of the contract.

All access routes into the site used by the work force and design team will be temporarily surfaced and fenced at all times.

We employ widely experienced operatives who undergo regular training and certification.

The majority of our workforce hold CSCS cards or CPCS and are undertaking NVQ Level 2 assessment at present.

MCL use a small selection of sub-contractors with established performance and safety records.

Sub-contractors are assessed and monitored to ensure compliance.

Safe working conditions and adequate welfare facilities are always provided

Protection of customers and the public by ensuring the site is safely cordoned

Workforce are consulted through MCL's H & S committee and regular toolbox talks.
